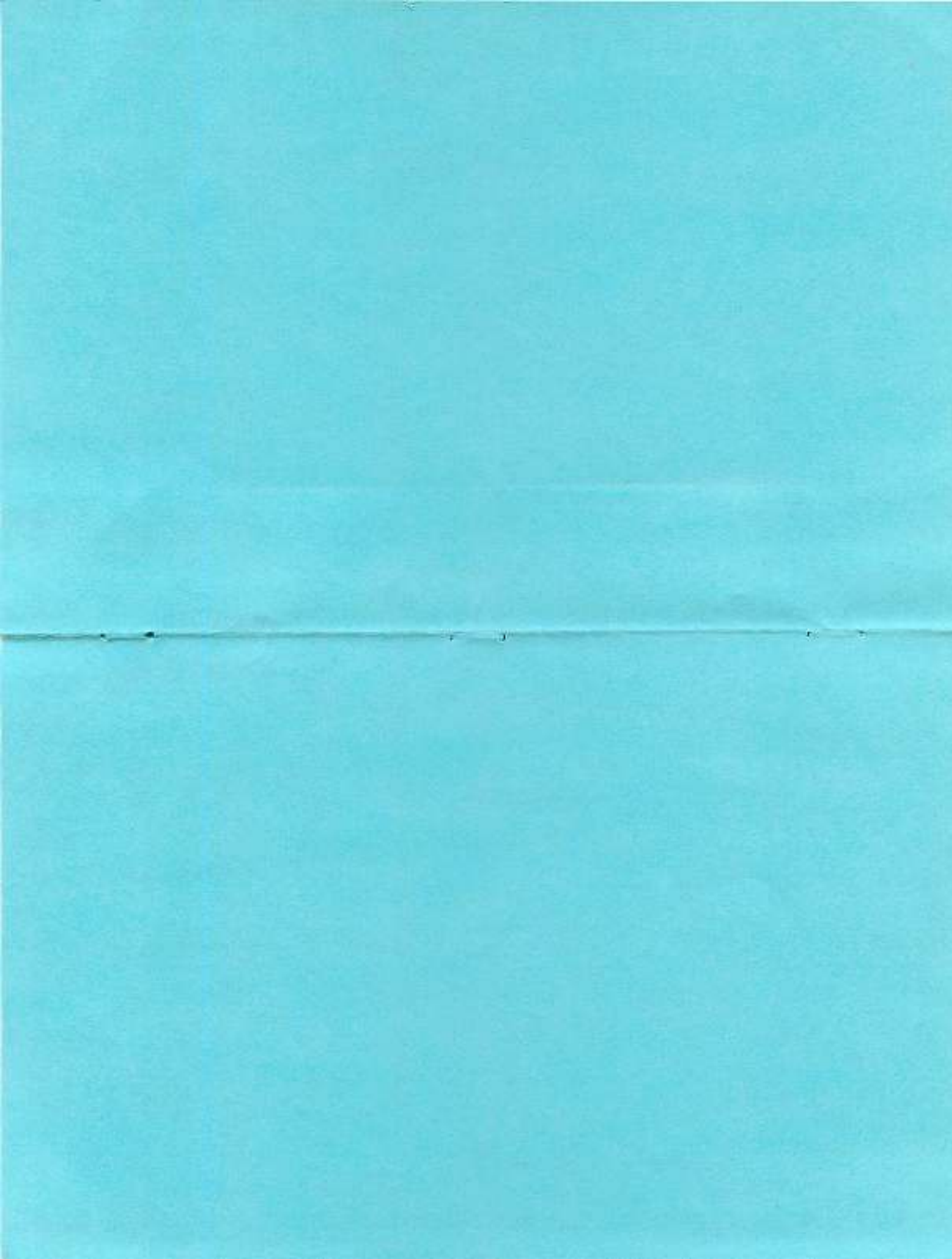

12. Life Members - Branch members who have become life members of the association through 50 years of continuous membership shall be exempt from payment of branch dues. Their division dues should be paid by the branch.

13. Luncheon Reservations - Individual members who cancel a luncheon reservation after the reservations are closed or turned in, are responsible for these cancelled reservations.

14. Meetings - A. Branch meetings shall be held on the 1st Thursday or 1st Saturday of each month. B. Board meetings will be held on the 3rd Thursday of each month. C. Meeting schedule: September - 1st Saturday that does not conflict with the Labor Day weekend. Interest group signup - Membership Tea. November - Progressive Dinner and report from Educational Foundation. January - Legislative committee report on resolutions to be presented at convention. February - Fellowship Luncheon. Present named Fellowship Grant. Nomination Committee report for coming year officers. March - New Officers elected. April - Elect delegates to state convention. May - Membership renewal brunch, installation of officers, convention reports, budget for next year.

15. New Members - Dues received after Jan 31 are applied to the fiscal year beginning July of that calendar year, if new members have not participated in branch activities prior to the end of January.

16. Political concerns - Discussion of legislative concerns pertinent to AAUW's purpose and program is to be encouraged. Political speeches of a partisan nature or endorsing particular candidates will not be permitted at branch meetings or through the newsletter.

17. President's Gift - The 1st V.P. and Treasurer shall be in charge of the selection of the President's gift up to the amount budgeted. This gift shall represent the appreciation of the entire membership and shall be

9. Educational Foundation Program - A. The educational foundation chairman shall have the responsibility of educating members regarding the AAUW Foundation Program, its structure, history, and importance, source of income, and ways members can designate and restrict the expenditure of such money. B. All monies specifically earned, contributed or in any way designated for the Educational Fund will be held in a separate account and not dispensed with operating expense monies. C. An annual \$500.00 named gift shall be sent to the Educational Foundation as revenue permits. All monies in the educational fund account beyond the \$500.00 minimum for a single named gift shall be distributed for such projects as: \$200.00 for Rogue Community College Nursing Program, additional contributions to the Educational Foundations Program, educational community or cultural needs in the valley (jail fund, KSYS, S.O. Arts Council, SOSO Scholarship) as voted on by the majority of the membership.

10. Financial Contributions - It shall be the general policy not to make contributions to other groups or organizations' projects except of an exceptional educational or cultural value. It shall be voted on by the majority of the membership.

11. Interest Groups - Branches may open their interest groups to women who are not eligible for AAUW membership. Guests participating in interest groups shall at no time; be considered members of AAUW Branch, be eligible for any rights of membership or serve as chairman of the interest group. The chairmen of the groups should be notified in advance. Women eligible for membership in AAUW may not attend an interest group after 3 meetings unless they join the Branch. If a member chooses not to continue to pay her dues, she may not continue to attend meetings, including interest group meetings.

AAUW POLICIES

1. Board Members - Board Members are expected to attend all branch and board meetings. Members who wish to propose a new item of business or deliver a report which may evoke considerable discussion are to give notice to the president in order to prepare it for the agenda.
2. Bylaws and Policies - It is the responsibility of the president and recording secretary to be thoroughly familiar with the branch bylaws and policies and to have them available for reference at every branch and board meeting.
3. Change of address, phone or name - This is to be reported to the membership chairman. The membership chairman will then notify the association, division, branch treasurer and newsletter editor.
4. Community Activities - It will be our policy to help in any way we can to cultural or civic projects.
5. Convention - Expenses will be paid in full regarding gasoline, (at a rate of 15¢ a mile) and registration for conventions. Meals and lodging will be apportioned as to number of delegates and amount budgeted for that year.
6. Courtesy - The corresponding secretary will send get well, sympathy, or congratulatory cards to members whenever appropriate. Plants, flowers, or other gifts are to be excluded.
7. Donations - No AAUW funds over \$50.00 will be expended without a 2/3 majority vote of membership. Individual membership or participation may be considered.
8. Dues - Deadline for payment of dues to the treasurer shall be July 1.
